Dear Mayor Copeland and District Attorney Howe:

The undersigned advocacy, civil rights, community, and faith-based groups are deeply saddened and troubled by a tragic shooting that killed one Indian man, and injured two others on February 22, 2017. We write to express deep concern about this attack, and respectfully urge you to direct your police department to investigate objectively, thoroughly, and efficiently to ensure that justice is served for the victims and their families.

According to media reports, Adam W. Purinton allegedly opened fire on Wednesday at a local establishment in Olathe killing Srinivas Kuchibhotla, a Garmin engineer from India. Mr. Kuchibhotla's friend and colleague, Alok Madasani, also from India, and another patron suffered injuries. At least <u>one witness has reported</u> they heard the shooter yell "get out of my country" and other racial slurs before opening fire. Another witness heard the suspect <u>say he killed two Middle Eastern</u> men before he was taken into custody.

At a time when hate crimes against South Asians, Arabs, Middle Easterners, and Muslims are occurring at alarming rates across the country, law enforcement officials must take these types of threats and crimes seriously. Faith communities have also recently been victims of violent attacks:

- There have been a series of threats sent to Jewish Community Centers across the country;
- Over 100 headstones were vandalized at one of the oldest Jewish cemeteries in Missouri last weekend; and
- A mosque in Tampa, Florida was intentionally set on fire causing significant damage to a prayer hall.

The death of Mr. Kuchibhotla comes on the heels of anti-immigrant sentiment and violence that has swept the United States at an alarming rate, and people across the country feel fearful.

We were pleased to hear that the Federal Bureau of Investigation has opened an investigation to determine whether or not this was a hate crime, but we cannot underscore enough the need for both federal and local law enforcement to thoroughly investigate all possible motives underlying this crime. If the investigators conclude that there is evidence to suggest that the shootings of Mr. Kuchibhotla and Mr. Madasani were motivated by bias, federal and state hate crime legislation require that this attack be prosecuted as a hate crime.
